INVITATION TO BID
EMERGENCY PURCHASE OF AIR PURIFIER MACHINES FOR USE AT RHU AND ISOLATION FACILITIES AT CALASIAO, PANGASINAN

1. The *Municipality of Calasiao*, through the **Loan from Landbank of the Philippines** intends to apply the sum of **ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Emergency Purchase of Air Purifier Machines for use at RHU and Isolation Facilities at Calasiao, Pangasinan**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Calasiao* now invites bids for **Emergency Purchase of Air Purifier Machines for use at RHU and Isolation Facilities at Calasiao, Pangasinan**. Delivery of the items is required **within Ten(10) calendar days upon issuance of Notice to Proceed**. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from *Municipality of Calasiao Bids and Awards Committee* and inspect the Bidding Documents at the address given below *from 8:00 A.M. to 5:00 P.M.*
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Pesos(P5000.00) from September 11-October 5, 2020**.
6. The Municipality of Calasiao Bids and Awards Committee will hold a **Pre-Bid Conference on September 21, 2020 at 9:00 A.M. at the BAC Office Ground Floor, Municipal Hall Building** which shall be open to prospective bidders.
7. **Bids** must be duly received by the BAC Secretariat at the address below **on or before 9:00A.M., October 5, 2020**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be at **9:01 A.M. October 5, 2020 at the BAC Office, Ground Floor, Municipal Hall, Calasiao, Pangasinan**. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

The Award shall be made after the perfection of the Loan Agreement with the Land Bank of the Philippines.

8. The *Municipality of Calasiao-BAC* reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
