The *Municipality of Calasiao*, through the **Annual Budget 2023** intends to apply the sum of ***Nine Hundred Ninety Eight Thousand Nine Hundred Seventy Six Pesos (P998,976.00)*** being the Approved Budget for the Contract (ABC) to payments under the contract for **Purchase of Fertilizers to be Distributed to Farmers at CalasiaoPangasinan(Reference No. 2023-01-30)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Calasiao*, through the **Annual Budget 2023** intends to apply the sum of ***Nine Hundred Ninety Eight Thousand Nine Hundred Seventy Six Pesos (P998,976.00)*** being the Approved Budget for the Contract (ABC) to payments under the contract for **Purchase of Fertilizers to be Distributed to Farmers at CalasiaoPangasinan(Reference No. 2023-01-30)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The *Municipality of Calasiao* now invites bids for the **Purchase of Fertilizers to be Distributed to Farmers at CalasiaoPanagsinan(Reference No. 2023-01-30)**. Completion of the Works is required ***Fifteen (15) calendar days***The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. Interested bidders may obtain further information from *Municipality of Calasiao* and inspect the Bidding Documents at the address given below from ***8:00A.M.to 5:00P.M.***
6. A complete set of Bidding Documents may be acquired by interested bidders on ***June28-July6, 2023*** from given address and website/s ***calasiao.gov.ph*** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ***One Thousand Pesos (1,000.00)***. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, or through email*.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before ***July 6, 2023 at 10:30A.M.***Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 16**.
9. Bid opening shall be on ***July 6, 2023 at 10:30A.M.***at the given address below. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.

The *Municipality of Calasiao* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
